2023 Property Tax Information

Dear Tax Payer,

The notice enclosed is a combination of Charlotte County ad valorem taxes collected for taxing authorities and non-ad valorem assessments collected for levying authorities. Tax roll opens for payment November 1st, 2023. The notice lists all the authorities that are included in your taxes. If you have a question regarding one of the charges on your notice, please contact that authority directly. Phone numbers for each authority are listed on your notice. You will receive a separate notice for each piece of property you own according to the way the deed is recorded. Please verify the legal description on the tax notice. If any tax notices are missing, please refer to our website to print any missing notices at taxcollector.charlottecountyfl.gov. If you have any questions regarding the recording of public records, including property deeds, contact the Clerk of Circuit Court at (941) 637-2335. Important Dates To Remember

Florida Law allows discounts for early payment of property taxes. The following discounts apply for early payment:

Nov 2023 - 4% Discount

Offices Closed: 10th Veterans Day 23rd & 24th Thanksgiving

Dec 2023 - 3% Discount

31st - 3rd Installment Payment Due Offices Closed: 25th & 26th Christmas

Jan 2024- 2% Discount

Offices Closed: Jan 1st New Years 15th Martin Luther King Jr. Day

Feb 2024 - 1% Discount

Offices Closed: 19th Presidents Day

Mar 2024 - Gross Tax Due (No discount applied)

31st Deferred Tax Application Deadline 31st - 4th Installment Payment Due

Apr 2024

Taxes become Delinquent April 1st - Add 3% 30th Deadline to file 2024 Installment Payment Applications

When a discount period ends (Nov - Mar) on a Saturday or Sunday or legal holiday, the discount period is extended to the next working day, if payment is delivered to the Tax Collectors office on the extended day.

Florida Forest Service

Pursuant to Florida Statue 590.125 (5), the Florida Forest Service will be conducting fuel reduction initiatives consisting of prescribed burning and mechanical treatment of selected parcels within Charlotte County. Prescribed burning will be conducted during the period of November 2023 through March 2024. Mechanical treatment may be performed at any time during the year. These treatments are to reduce the fire occurrence hazard and to establish fuel continuity breaks. Parcels with structures or improvements will not be designated for prescribed burning. This service is provided at no cost to the landowner.

2024 Installment Payment Plan

To pay property taxes by installment quarterly, June, September, December, and March, please complete the application below or online at taxcollector.charlottecountyfl.gov. Return the application to your tax collector by April 30th. The tax collector will send your first notice of payment due on or before June 1st, with instructions. If you have not received your first notice by June 15th, contact the Tax Collector's Office at (941) 743-1350 or email us at taxcollector@charlottecountyfl.gov.

Florida Law requires that your estimated taxes must be more than \$100.00 per tax notice in order to participate in the Installment Payment Plan. If your estimated taxes are \$100.00 or less, you do not qualify for this plan. You must make the first installment payment no later than June 30th in order to participate in this plan. Once you have elected to participate in the installment payment plan by timely paying the first payment, you are required to continue participation for the tax year. If you elect to discontinue participation, you will not be entitled to receive the discounts provided by law. Installment payments that become delinquent shall be paid with the next installment payment. Discounts will not be allowed on delinquent payments.
